## Final Terms of August 15th 2019 for certain Bonds issued by Jyske Realkredit

The full prospectus for the Bonds consist of "Base Prospectus for covered bonds and mortgage bonds issued by BRFkredit a/s", dated 1. February 2017, including any addenda to the said Base Prospectus as well as the Final Terms outlined below. Prepayment of loans results in either an extraordinary redemption of Bonds at par value or cancellation of Bonds in Jyske Realkredit's own holding. The Bonds will be finally redeemed

no later than on the maturity date.
